- All NFTs will be sold on the open market and OpenSea.



# TOKEN UTILITIES AND NFTS

Our goal is to make IBIKS a completely useful token, that is why in order to participate or to be part of any privilege of the platform it will be necessary to possess certain amounts of the token in question.

We know that perhaps not everyone will be able to acquire certain amounts of the token to be able to participate and that is why we will provide the opportunity for people who do not have the same resources to collaborate with the company and be able to produce tokens without the need for capital.

## **We will do it in the following way :**

### **P2E GAMES :**

Possibility of generating INOK tokens through the games launched from the platform, being the same platform the one who lends its blocked tokens to these players in exchange for a percentage. In each game will be given a certain number of places by lottery to meet the requirements of the platform as being subscribed to the official channels and share on their social networks.

Also on a monthly basis we will put different tasks with free accessibility for everyone in order to bring the community closer to the business. Each task will be available for a period of time and we will reward 100% of the users who comply with them.

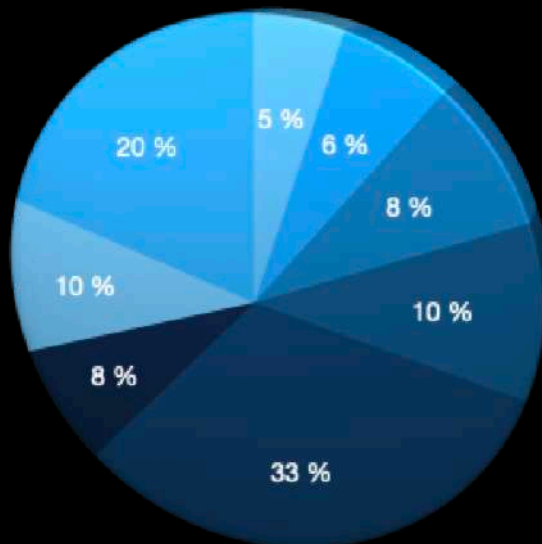

# OUR TIERS



One of our conditions is that to be part of INOKBISS it is necessary to maintain in stake at least the lowest level of our table and keep it for at least 60 days although there is always freedom to leave the stake there is a penalty subject to a 25%.

In case of unstake before the end of the lockout time this percentage will be burned and therefore will benefit those who do maintain their position.

We do this so that users who do not intend to participate in the project do not take advantage of arbitrage and speculation because as we mentioned before we will make periodic burns warned by the community channels.
